## RULES AND REGULATIONS

Corporate showcase sessions are presented theater style, slotted for 30 minutes, and given to 50 attendees at a time. The showcase fee includes space rental and listing on onsite signage that features *all* corporate showcases listed in the AAPM Annual Meeting Program Guide.

All activities are restricted to the designated area in the AAPM Resource Center. Your showcase will include a podium, microphone, sound system, projection, 8' screen, and one lead retrieval machine. You are responsible for any special-need charges (e.g., catering, additional audiovisual equipment, etc.).

Promotion of your showcase is your responsibility. Signage no larger than 28' x 44' may be placed in the registration area, at the entrance of the Resource Center (exhibit hall), and outside the designated area 24 hours before your showcase is scheduled to begin. You may promote your showcase through direct mail, room drop, or program book advertising for an additional fee.

Sessions are approved on a first-come, first-served basis. Showcases are only available to AAPM exhibitors. No cancellations are accepted after space is confirmed. **The fee is \$5,500.**
